OVERVIEW

The International Public Sector Accounting Standards (IPSAS) are intended to facilitate credible and high-quality financial reporting that is transparent and allows users the ability to hold government entities accountable. Furthermore, the standards require that more information be provided and disclosed in an entity's financial statements, leading to better information availability and transparency for decision-making.

Uganda Adopted the IPSASs in 2006. The initiative to implement IPSASs is a significant undertaking that necessitates the establishment of effective governance frameworks and governance arrangements. The transitional arrangements are already in place.

The Handbook of International Public Sector Accounting Pronouncements is the primary authoritative source of international generally accepted accounting principles for public sector entities. The webinar will provide an overview of the most important requirements for preparing financial statements and disclosures under IPSAS.
