Stamp Duty Scrapped

The Institute of Certified Public Accountants of Uganda informs practitioners, members and students that the Stamp Duty charge of UGX 100,000 on professional licenses/certificates (that had been charged to practitioners) has been scrapped following the Constitutional Court judgement in Constitutional Petition No. 032 of 2020; Uganda Law Society and 12 others versus Attorney General (ICPAU is among the 12 others). The judgement was delivered on 13 February 2024.

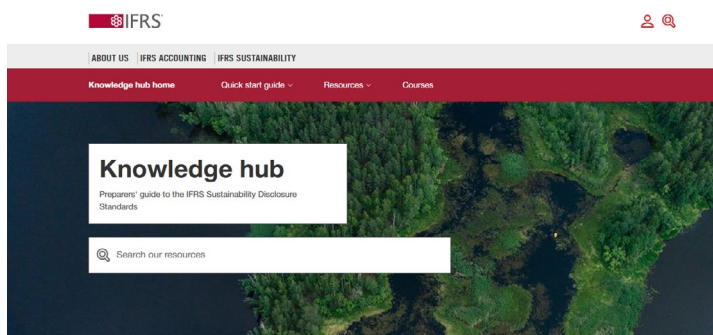

INPAG Exposure Draft 2 response period will close on 15 March 2024

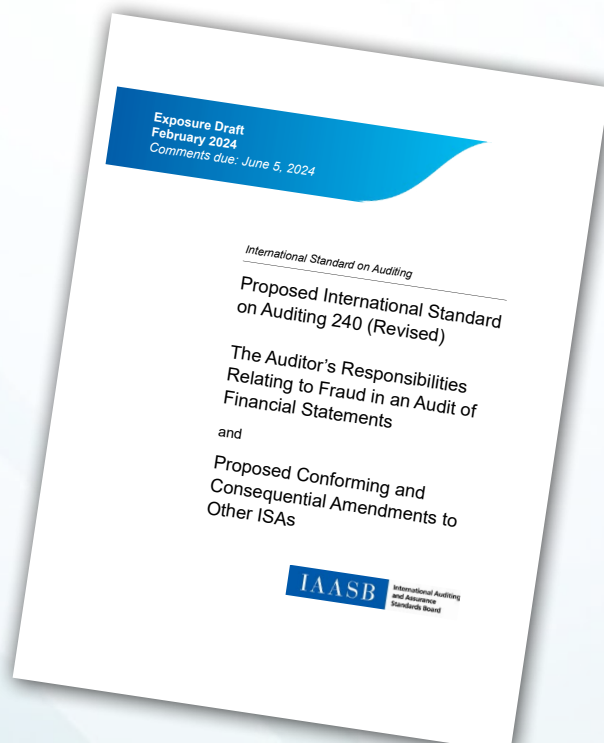

AUDITING & ETHICS

IAASB moves to strengthen Auditor's Efforts related to Fraud

The International Auditing and Assurance Standards Board (IAASB) has proposed a significant strengthening of its standard on auditors' responsibilities relating to fraud. The proposed revisions significantly strengthen the auditor's fraud-related responsibilities by defining the expectations, delineating more robust procedures, and increasing transparency in the auditor's report. The [Exposure Draft](#) is open for comment till June 5, 2024.



Proposed International Ethics Standards for Sustainability Assurance (Including International Independence Standards) and Other Revisions to the Code relating to Sustainability Assurance and Reporting

The International Ethics Standards Board for Accountants (IESBA) is conducting public consultation on the proposed framework of expected behaviors and ethics provisions for use by all sustainability assurance practitioners regardless of their professional backgrounds as well as professional accountants involved in sustainability reporting. Using the Work of an External Expert



The International Ethics Standards Board for Accountants (IESBA) is conducting a public consultation of the proposed ethical framework to guide professional accountants or sustainability assurance practitioners in applying the Code's conceptual framework when using the work of an external expert. 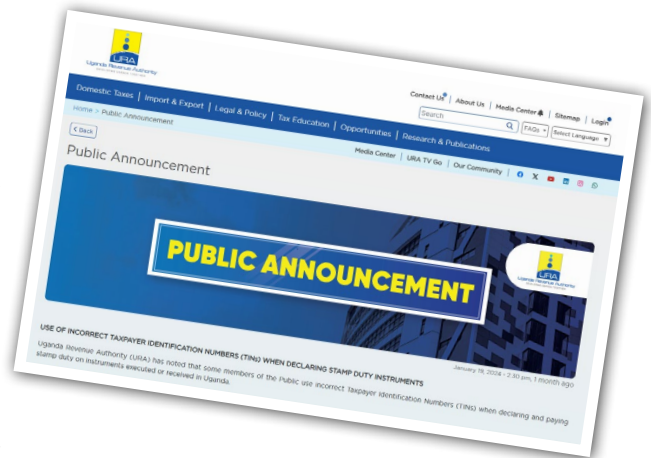
IPSASB Issues two Exposure Drafts related to Natural Resource Project

The International Public Sector Accounting Standards Board (IPSASB) released ED 86 and ED 87 for public comment. ED 86, Exploration for and Evaluation of Mineral Resources proposes a standard on accounting for the costs incurred in the exploration and evaluation of mineral resources; while ED 87 Stripping costs in the Production Phase of a Surface Mine (Amendments to IPSAS 12) proposes adding an authoritative appendix to IPSAS 12, Inventories. The EDs are open for comments till April 30, 2024.



USE of incorrect Taxpayer Identification Numbers (TINs)

Uganda Revenue Authority (URA) issued a public notice to inform the general public that any person who executes an instrument, purchases or transfers property is required to use a correct TIN to declare and pay stamp duty. This came as the authority noted that some members of the public continued to use incorrect Taxpayer Identification Numbers (TINs) when declaring and paying stamp duty on instruments executed or received in Uganda [Read more..](#)





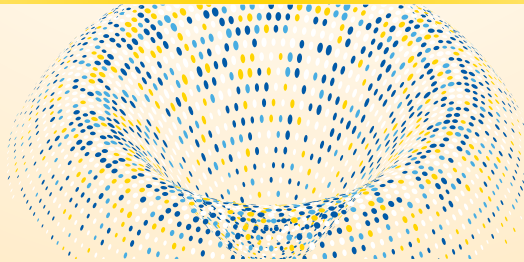
