#### **1.0 BACKGROUND INFORMATION**

#### I.I Institute's Profile

The Institute of Certified Public Accountants of Uganda (ICPAU) was established in 1992 by an Act of Parliament, now The Accountants Act Cap 294. ICPAU is governed by a Council, which is assisted by the Members Services Committee, Public Accountants Examinations Board (PAEB), and other committees.

The functions of the Institute, as prescribed by the Accountants Act Cap 294 are:

- a) To regulate and maintain the standard of accountancy in Uganda
- b) To prescribe and regulate the conduct of accountants and practising accountants in Uganda.

#### 2.0 MEMBERSHIP CATEGORIES

ICPAU membership categories are;

- a) Full Membership
- b) Associate Membership
- c) Honorary Membership
- d) Retired Membership

#### 2.1 Full Membership

To become a full member, you must either:

a) Be a CPA(U) graduate with at least 3 years of practical training as pre- scribed by the Council.

#### OR

b) Be a full member, in good standing, of any of the East African Community Institutes of Accountants (EACIAs): the Institute of Certified Public Accountants of Kenya, Institute of Certified Public Accountants of Rwanda, the National Board of Accountants and Auditors of Tanzania and Ordre des Professionnels Comptables du Burundi (OPC Burundi). EACIAs members should have attempted and completed the CPA course related exams in their mother bodies.

**NOTE:** Holders of Foreign Accountancy Qualifications (FAQs) may be required to sit for all or some of the following CPA(U) course papers: Business & Company Law - CPA Paper 5, Public Financial Management - CPA Paper 13, Audit Practice & Assurance - CPA Paper 16 and Advanced Taxation - CPA Paper 17 and Advanced Financial Reporting - CPA Paper 12.

#### 2.3 Associate Membership

A person is eligible for associate membership when they complete the CPA(U) course but do not have Practical Experience Training prescribed by the Council.

#### 2.4 Requirements for Full Membership Application

- a) A print out of the duly completed and signed online application form.
- b) Proof of payment of enrolment fees.
- c) Completed Practical Experience Training (PET) logbook
- d) Curriculum Vitae (CV).
- e) One (1) colour photograph (passport type with white background)
- f) Recommendation letters from:
  - (i) Either current employer or former employer within the past three years,

and;

(ii) A full member of ICPAU in good standing, known to the applicant personally.

**NOTE:** If the applicant has been with their current employer for a year and a half, the recommendation letter should come from that employer.

Section 34 (2) of the Accountants Act states that:

All heads of accounts, finance and internal audit in public and private sector entities, with public interest, shall be members of the Institute in accordance with the regulations made under this Act.

#### **4.0 MEMBERSHIP FEES**



**Enrolment fees** must be paid on application. In case you are unable to pay these fees at once, you can pay in installments to your ICPAU account, and submit your application form upon making the required payments.

**Development Fund** contribution may be paid before or after one has been admitted to the membership. However, membership certificates are issued upon full payment of the Development Fund.

**Annual subscription fees** are due and payable on the 1st day of January every year, and in any case not later than the 31st day of March.

#### Note:

There is no payment of annual subscription fees in the year of enrolment.

#### 5.0 PRACTISING ACCOUNTANCY

#### 5.1 Registration as a Practising Accountant

A person who is enroled as a full member of the Institute, and wishes to practise accountancy may apply to the Council to be registered as a practising accountant. (Section 27 of the Accountants Act)

#### 5.2 Firm Licence

A person holding a valid Certificate of Practice who wishes to establish an accounting firm, whether as a sole practitioner or in partnership, may apply to the Council for an annual licence furnishing it with details of the firm. In case of a partnership, all the partners possess valid Certificates of Practice. (Section 31 of the Accountants Act)

#### 5.3 Renewal of Certificate of Practice and Firm Licence

In Line with Section 32(1) of the Accountants Act, application for Renewal of Certificate of practice and firm license is made at least two months before the end of the financial year in respect of which the Licence is issued.

#### 6.0 ICPAU Regional Members Networks

ICPAU Regional Members Network is a formal arrangement of members of the Institute of Certified Public Accountants of Uganda who work, reside or hail from a region guided by a constitution approved by the Council of ICPAU to champion accountancy and other issues that affect a particular region.

Regional Members Networks were introduced in 2016 by ICPAU to improve member engagement.

#### 6.1 The objectives include the following;


- i. To improve member engagements by acting as a communication link for the Institute and its members.

# JOIN THE ICPAU BENEVOLENT FUND

## **BENEFITS**

The fund shall provide financial assistance as follows:

Details	Amounts (Ushs)	
In the event of death of a member	Up to but not exceeding Ug shs.6,000,000	
Death of the member's Spouse	Up to but not exceeding Ug shs.4,000,000	
Death of the member's biological or adopted child (up to a maximum of four (4) children)	Up to but not exceeding Ug shs.2,00,000	
Incapacitated member	To be determined by the Board depending on the circumstances but not exceeding twice the death benefit.	

In the case of financial assistance sought on grounds of incapacitation, it must be proved that the member cannot afford (as a result of his or her present circumstances) his or her immediate needs.

3. A member who is a George W. Egaddu Fellow shall be accorded additional bereavement support of fifty percent (50%) of the applicable amount stated above.

A member who is a Pius K. Bahemuka Fellow shall be accorded additional bereavement support of twenty -five percent 25% of the applicable amount stated above.


