RELEASE OF MAY 2024 EXAMINATIONS RESULTS

TUESDAY, 18 JUNE 2024

The President, Members of Council, Members of PAEB, Staff of the Secretariat, Members of the Press, Ladies and Gentlemen.

1.0 INTRODUCTION

On behalf of Public Accountants Examinations Board (PAEB) and on my own behalf, I wish to welcome you to the release of the May 2024 examinations results. We have a plan of conducting three (3) examinations diets this year 2024, that is May, August and November. We have concluded the May diet, and are here today to release the results for that diet.

Before we go into the details of the results, there are some few, important issues that the board wishes to highlight.

2.0 STUDENT ENGAGEMENT

Some of the interventions to address students performance are students engagements and tuition providers engagements.

This year, we have organised a series of student engagement activities. The first series were run in

February and March, with a total of 2,593 attendees out of the expected 10,195; representing 25.4% attendance. These were free engagement activities.

We have noted that students that attended engagement activities performed better in examinations. We also noted that many students that attended engagement for a given subject are not necessarily those that are registered to sit the immediate forthcoming examinations! For instance, for CPA Paper 12 - Advanced Financial Reporting, only 5.1% of those who attended the engagement activity (webinar) sat for the May 2024 examinations. The rest (94.9%) did not register to sit for this paper at this examinations diet.

We wish to encourage students to attend engagement activities, because it is one of the ways put in place by PAEB to help students appreciate what is required and subsequently improve performance in the various subjects.

3.0 MASTERCLASSES

As we promised at the release of the November 2023 examinations results, we have conducted a masterclass in pedagogy for tuition providers. The class concluded on Saturday, 15 June 2024 in Kampala. We shall make a full report in due course, but this is one of the interventions PAEB hopes will improve students' performance in examinations.

4.0 MAY 2024 EXAMINATIONS

The May 2024 examinations were conducted from Monday 20 to Friday 24 May 2024 at all the seven (7) examinations

centres of Arua, Fort Portal, Gulu, Kampala, Mbale, Mbarara and Nkozi.

A total of 6,375 candidates sat for the various papers representing an increment of 152 candidates (2.4%), compared to the 6,223 candidates who sat the November 2023 examinations. These were divided amongst the three courses as 121 ATD, 113 CTA, and 6,141-CPA.

5.0 EXAMINATIONS RESULTS IN DETAIL:

(a) ACCOUNTING TECHNICIANS DIPLOMA (ATD)

The average pass rate was 54.7% compared 51.2% in November 2023.

The 121 candidates who sat the ATD examinations presented a total of 274 scripts, of which 176 (64.2%) were by female candidates and 55 (35.8%) by male candidates.

150 of the 274 scripts registered passes. Of these 150 scripts, 95 (63.3%) were for female candidates while 55 (36.7%) were for the male candidates.

In terms of age, 52% of the passes were scored by candidates in the age bracket of 18—24 years, followed by candidates in the age bracket of 25—29 years at 37.3%). The remaining 10.7% were by candidates of 30 years and above.

Of the 150 registered passes 81 (54.0%) were scored by candidates attempting their papers for the first time.

Note that the recognition mark for the top position for each subject/paper is a minimum of 60%. The results show that Five (5) (41.7%) of the 12 top positions were taken by female candidates while seven (7) (58.3%) were taken by male candidates.

Seventeen (17) students completed the ATD course compared to nine (9) in November 2023. Of the 17 students, 11 (64.7%) are female and 6 (35.3%) are male.

The cumulative number of students who have completed the Accounting Technicians course has now reached 1,857.

It is important to note that ATD is being conducted by UBTEB as well and we are in transition. No new students are being registered by ICPAU and the current students have up to the end of 2025 to complete the course. Otherwise, they will have to join UBTEB examination centres.

(i) Performance in the individual subjects:

The average pass rate has improved from 36.2% in November 2023 to 52.3% this May 2024 sitting.

Altogether, the 113 CTA candidates presented a total of 214 scripts, of which 112 (52.3%) registered passes.

65 of the 112 scripts that registered passes (58%) were presented by candidates attempting their papers for the first time.

The average pass rate has improved from 38.5% in November 2023 examinations diet to 43.7% in May 2024 exams diet.

The 6,141 CPA candidates who sat the May 2024 examinations presented a total of 10,678 scripts. Of these scripts, 5,986 (56.1%) were by female candidates and 4,692 (43.9%) by their male counterparts. 4,668 scripts registered passes.

3,070 of the 4,668 scripts that registered passes (65.8%) were presented by candidates attempting their papers for the first time.

In terms of age, 772 (16.5%) of the passes were scored by candidates in the age bracket of 18–24 years, 1,981 (42.4%) by candidates in the age bracket of 25–29 years, and 1,197 (25.6%) by candidates in the age bracket of 30–34 years. The remaining 718 (15.3%) of the passes were scored by candidates above 34 years of age. We note here

that the age bracket of 25—29 years forms the bulk of the active students on the CPA course. Most of these are fresh graduates from institutions of higher learning.

(ii) Top candidates per subject:

Twelve (12) (57.1%) of the 21 top positions were taken by female candidates and 9 (42.9%) by male candidates.

81 students completed the CPA course compared to 76 in the November 2023 examinations. Of the 81 students who completed the course 41 (50.6%) are female and 40 (49.4%) are male.

The cumulative number of students who have completed the CPA course has now reached 5,051.
